  - b. In the case of advertising in web sites, the advertiser undertakes not to advertise in the web sites of UAE-based publishing houses or its subsidiary/associate companies (other than that of Al Nisr Publishing LLC and its subsidiary/associate companies).
- 7. Expenditure Commitment must be fulfilled to be eligible for the applicable discount rate as indicated above.
- 8. Debit/Credit will be issued at the end of the Agreement period depending on actual performance and the corresponding effective rate. The credit note cannot be encashed but can only be adjusted against expenditure in products/services of Al Nisr Publishing LLC and its subsidiary/associate companies.
- 9. An agency signing on behalf of the advertiser is responsible for maintaining the commitments, inclusive of advertising released by the advertiser, directly or through other agencies.
- 10. Payment Terms: Prepayment. Credit, if approved, will be for maximum 30 days from the date of invoice.
- 11. Any revision in the terms of the Agreement will be mutually agreed to by both the parties in writing.
- 12. The Conditions of Acceptance of advertisements, which forms part of this Agreement, have been read, fully understood and agreed.
- 13. The Agreement is applicable only for the UAE.
